I would like to take this opportunity to thank the elected and appointed members of the Lansdowne Democratic Committee for selecting me as the new Chairperson, especially in the year we celebrate our 20th Anniversary of Lansdowne Democratic leadership of local

Prior to 1997 and dating back to our incorporation as a Borough in 1893, local government was under the majority (and sometimes exclusive) control of the local Republican party. It was only in the early 1990s that the first Democrat was elected to serve as a Borough Council person. By 1997, with the establishment of the Lansdowne Leader, increased activism by the loyal opposition, and growing awareness by the citizens of the borough, local Democrats were awarded a majority of seats on Borough Council, the Mayor's office, the Constable position and one of three Auditor positions. Since that time, the members of the Democratic party have worked hard to lead the borough in a progressive direction, maintain open and accountable government and pursue an agenda that is welcoming to diverse populations and progressive ideas.

I am proud to be one of the founding members of the Lansdowne Leader editorial board where I served as managing editor for over ten years. I also served as Borough Auditor (elected in 1997), served a two year stint as an appointed member of Borough Council where I chaired the Community Relations Committee and led the rebuilding of Hoffman Park after Hurricane Floyd. Since that time I ran (unsuccessfully) for State Representative (1998) on the platform of equitable funding for public education and in 2001 I was elected to the William Penn School District Board where I have served for nearly 16 years.




positive reentry to prevent recidivism. She attended public schools and graduated from Temple University JD, LLM, and Eastern University MBA programs.

Local Candidates Endorsed by Lansdowne Democratic Committee

The Lansdowne Democratic Committee (the Committee) meets on the second Monday of each month year-round to conduct political business in Lansdowne. One of the most important jobs that we perform involves getting Democrats elected at all levels of government. This year is a local election, sometimes referred to as an off-year election because it does not have the high profile of a presidential, senatorial or gubernatorial election with associated daily bombardment of political ads. Don't be fooled by the media hush on local elections as they are often the most impactful in our day to day living. And here's how the Committee is working on your behalf to recruit and promote trusted local candidates for local office.

Local positions open on the May 16th primary ballot include four Borough Council seats, Mayor, School Director and Tax Collector.

Local positions open on the primary ballot this spring include four Borough Council seats, Mayor, School Director and Tax Collector. At the January Committee meeting a discussion ensued about helping those who were reeling from the presidential election results and channeling their dissatisfaction into local political action. To that end an ad hoc group was formed to solicit new Democratic volunteers, inform the public of the openings, and to create a system to pre-screen candidates. Edie Ferebee, Suzanne McElroy and Jayne Young volunteered to undertake this work. Social media was utilized for this purpose, followed up by personal contact. A questionnaire was developed and used for all

potential candidates seeking the endorsement of Committee, whether new or those seeking re-election. Interested and eligible candidates came to the February Committee meeting to meet all members and seek their support. In some cases, there were more candidates than offices

A special endorsement meeting was scheduled for Committee members. At this meeting there was a quorum and the first step was to vote on whether or not the Committee should have an open primary. That would mean that the Committee would take a hands-off approach and let all individual candidates run without our help (physical and financial) or our endorsement. The Committee takes its role seriously and voted overwhelmingly to endorse a slate of candidates for the primary.

The endorsed candidates above are the results of this process. The Committee proudly endorses each one for local office and hopes that you will support them with your vote on May 16.

A Clarification Regarding the Tax Collector Race

There were two Democrats interested in running for the position of Tax Collector. Both submitted applications and both were vetted by the nominating committee. It is important to note that both Democrats who were seeking the position of Tax Collector – Bill Smith and Robert Radich - voted in favor of Committee endorsing for just one of the two vying for the seat.

The vote was conducted by written ballot. Prior to the vote, each candidate indicated that they would support the other if they were not selected. The vote was close, with Bill Smith winning over Robert Radich. This was not surprising since both candidates were vetted and qualified.

Shortly after the endorsement meeting, Robert Radich decided that he would run for the position without an endorsement, despite having pledged his support of the winner of the process. As part of the process to get a position on the ballot, Mr. Radich failed to file both a financial disclosure form in the Borough Offices (required by law) and failed to file a State Police criminal record with his nominating petition in the County Election Board (also required by law). Mr. Smith challenged his nominating petition and the Common Pleas Court ruled to remove Mr. Radich from the primary ballot based on his failure to follow the election law.

Subsequently, Mr. Radich has decided to run a write in campaign. In various social media postings, he has disparaged Mr. Smith's qualifications by citing decadesold financial filings (liens against him) and implying that Mr. Smith was terminated by the Borough from the position of Borough Treasurer when he held that position many years ago.

In the first instance, Mr. Smith's financial issues were of a very personal nature – resulting from medical and family custody matters. All judgments have been cleared. In the second, the record is clear that while Mr. Smith was serving as part-time Borough Treasurer, it was he, himself who recommended that the position be made full-time and that the Borough hire someone to take over that position. When this transition was substantially completed, Mr. Smith's services were obviously no longer

needed and he left the position for a similar one in a neighboring Borough.

We publish this information so that the public is aware that facts matter and that trying to win elections by disparaging one's opponent is not the way the Lansdowne Democratic Committee conducts itself. We commend our endorsed slate of candidates for their willingness to serve their community, their qualifications and their commitment to positive campaigning. We ask that you endorse them as well with your vote on May 16.

two older fire trucks with new ones. In addition the committee was able to show PennDOT that the intersection of Marshall Road and Owen Avenue was a dangerous intersection with numerous accidents. Along with Lansdowne's State Representative Davidson in cooperation with Upper Darby Township and stop signs and flashing lights were installed. This has

dramatically decreased the number of accidents and the severity.

Refugee Assistance and Immigration Counseling Available in Lansdowne

PRIME ECR (Ecumenical Commitment to Refugees) is a not-for-profit [501(c) (3)] corporation that provides affordable or free services to assist refugees with safe, legal immigration solutions. PRIME was founded in Philadelphia in September 1983. At that time, its goal was the resettlement of refugees who had passed an immigration interview overseas and who were permitted to enter the United States.

Since 1992 the Board of Immigration Appeals (a division of the US DOJ) has recognized PRIME as a provider of immigration counseling and, starting in 1996, PRIME staff members have been accredited to represent before the DOJ's Immigration Courts. Over the years, as the staff of PRIME gained experience in representing immigration and refugee clients, they found many of their clients are not able to pay typical

immigration lawyer fees; as a non-profit, our fee schedules are set to assist as many refugees as possible with our limited resources.

In line with our determination to assist the uprooted and refugees, we have focused, since 2005, on helping clients who would otherwise not be aware of the steps needed to legally immigrate into the USA. We provide help with preparing and submitting all necessary forms and documents (e.g. leading toward Green Card, Naturalization) including travel documents and even overseas processes.

We also can provide legal representation with immigration services and in Immigration Court. We work with immigrants in English, Farsi, Spanish, French, and German – and can provide translators for other languages. We are also familiar with Canadian Immigration Programs.
